Library employees will judge the contest. Adults and students are eligible to receive the cash award of \$300 for the first place entry. Cash awards of \$200 and \$100 will be given for second and third place entries. Winning images will become the property of Kokomo-Howard County Public Library.

All pictures of Howard will be posted on the Kokomo-Howard County Public Library's web site at the conclusion of the contest. Any entry that does not meet the contest requirements, or contains material that is not appropriate, will be eliminated. **Submission Rules for Howard Contest:**

1. All artwork must be submitted to Dustina Stout at the Kokomo-Howard County Public Library, 220 N. Union Street, by Monday, January 30 at 5 p.m.
2. Artwork must be submitted on paper no larger than 8 1/2 x 11. Any media is acceptable, but all images must be two-dimensional. Computer-generated artwork must be 8 1/2 x 11 and at least 300 dpi. Acceptable file formats include: eps files, Adobe Photoshop, and Adobe Illustrator. If you wish to use a different program or file format, please contact Dustina Stout at 457-3242 or [dustina@kokomo.lib.in.us](mailto:dustina@kokomo.lib.in.us). Multiple submissions will be accepted.
3. Any submissions mailed to the library must be in a large flat envelope. Folded, wrinkled, or torn artwork will not be accepted.
4. Artwork of Howard should be a recognizable interpretation of the photographs provided. The image should contain at least one child, Howard in a friendly pose, and the library logo. The logo can be used in the background, or on a piece of Howard's clothing. The logo does not need to be an exact replica, but should be recognizable as the Kokomo-Howard County Public Library's official logo. Acceptable logo colors are white, blue and/or black.
5. Cash prizes will be awarded to first, second and third place winners. Adults and high school students are eligible for the cash prizes.
6. Winning images will become the property of Kokomo-Howard County Public Library. All other submissions can be picked up at the Kokomo-Howard County Public Library's Administrative Offices beginning Monday, February 13. Entries not picked up by Friday, February 17 will become the property of Kokomo-Howard County Public Library. Office hours are 9 a.m. to 5 p.m.

**In order to maintain that the winning Howard images are clearly associated with the Kokomo-Howard County Public Library, the winning images will become the property of the Kokomo-Howard County Public Library. The use of a winning image by the original artist in other contests or projects is prohibited.**
